## SUPPLY CHAIN POLICY FOR ALFION SA

### 1. Introduction

- respecting human rights and avoiding contributing to conflict through our sourcing practices,

## 4. Supply Chain Due Diligence

We will conduct due diligence, following a risk-based approach to identify, assess, and mitigate risks in our supply chain. This includes:

# 1. Establishing Strong Management Systems

- o Adopt and communicate our supply chain policy to suppliers and stakeholders.
- o Assign senior management responsibility for due diligence processes.
- o Establish internal systems to track and manage diamond supply chain data.

## 2. Identifying and Assessing Risks in the Supply Chain

- o Map our supply chain to understand the origin of diamonds and the conditions under which they are extracted, transported, and traded.
- o Conduct risk assessments to identify areas of potential human rights abuses, conflict financing, and environmental risks.

# 3. Designing and Implementing a Strategy to Respond to Identified Risks

- Develop and implement risk management strategies tailored to specific risks identified.
- Engage with suppliers to address and mitigate risks, providing training and support where necessary.
- Monitor and track the effectiveness of risk mitigation measures.

## 4. Carrying Out Independent Third-Party Audits

- Ensure that high-risk suppliers undergo independent third-party audits to verify compliance with our supply chain policy and relevant standards.
- o Review audit reports and take appropriate actions based on findings.

## 5. Reporting on Supply Chain Due Diligence

- Publicly report on our due diligence efforts and the measures taken to address risks in our supply chain.
- o Ensure transparency by providing stakeholders with relevant and accurate information.

## 5. Supplier Requirements

Alfion SA requires all suppliers to:

- comply with our Supplier Code of Conduct, which includes ethical, social, and environmental standards,
- provide transparent information about their supply chain, including the origin of diamonds,
- participate in due diligence processes and cooperate with risk assessments and audits,
- implement corrective actions to address any identified risks or non-compliances.

We will immediately stop engaging with upstream suppliers if we find a reasonable risk that:

- they tolerate, profit from, contribute to, assist or facilitate the commission of:
  - o torture, cruel, inhuman and degrading treatment,
  - o forced or compulsory labor,
  - o child labor,
  - o human rights violations and abuses,
  - o war crimes, violations of international humanitarian law, crimes against humanity or genocide;
- they are sourcing from, or are linked to, any party providing direct or indirect support to non-state armed groups.

#### 6. Grievance Mechanism

We have established a grievance mechanism to allow stakeholders to report concerns related to our supply chain. Reports can be made anonymously and without fear of retaliation to <a href="mailto:info@alfion.ch">info@alfion.ch</a>. All reports will be investigated, and appropriate actions will be taken to address substantiated concerns.
